Complaints have been received so your respect for your neighbors is requested.



#### **ARC** Guidelines

Recently, questions have been raised about the ARC Guidelines. The following is offered to hopefully help explain what the ARC Guidelines are and their basis.

Our Arbor Springs Covenants requires that we have an Architectural Review Committee (ARC) consisting of five (5) members. The ARC has the task of overseeing "(a) the external design, construction, appearance and location of the Dwellings, buildings, structures, and improvements on the Lots; and (b) the removal or addition of any tree, vegetation or landscaping feature or element, from or to any Lot." The ARC is required to create and establish standards or "guidelines" for the review, approval, and completion of the task referred to above.

Our Arbor Springs ARC has created the "guidelines" required by our covenants. The ARC Guidelines, which is how they are referred, were developed to be in compliance and consistent with the provisions of our Covenants, in particular, Article 6 - *Protective Covenants and Use Restrictions*. Some of the items covered by the Guidelines include basketball goals, hot tubs, fences, decks, outdoor living areas, pergolas, driveway expansions, mail boxes, trash can placement, and parking of trailers.
