#### GOLF CARTS ON PUBLIC STREET

A quick reminder - When driven on public streets, which Arbor Springs Subdivision are, golf carts are prohibited unless the (1) driver is 16 years of age and holds a valid driver's license; (2) golf cart is properly licensed, plated, and contains proper operating equipment; and (3) driver obeys all applicable laws. ## BROWNSBURG SEWER BILL CREDIT

The Brownsburg Town Council has authorized a onetime-a-year sewer credit for those customers who utilized water that did not enter the sewage system. In most instances, this would apply to customers who fill pools and/ or have lawn watering systems.
